TERMS AND CONDITIONS

FINAL LEGAL-DRAFTING VERSION — FOR ATTORNEY APPROVAL BEFORE PUBLICATION

This document consolidates the wording supplied for the Sugar Baby Online website with the prior drafting work. The Privacy Policy has been expanded to match the same level of detail, structure and legal-protection approach as the Terms and Conditions. It should be reviewed by qualified counsel before publication.

1. Platform Identification

Sugar Baby Online ("Sugar Baby Online," "the Platform," "we," "us," "our," or the "Company") is a technology platform that allows adults to create profiles, communicate, interact, and establish connections with other users.

These Terms constitute a binding agreement between the user and the entity responsible for the Platform. By creating an account, using the Platform, purchasing a membership, sending messages, uploading content, or using its services, the user confirms acceptance of these Terms.

2. Age Requirement and Adult-Only Use

The Platform is strictly limited to persons who are at least 18 years old and legally capable of entering into these Terms. Registering for a minor, facilitating a minor's access, soliciting a minor's photographs or personal information, or using the Platform for exploitation, trafficking, prostitution, abuse, or any unlawful activity is prohibited. Sugar Baby Online may request age or identity verification and may suspend or terminate accounts where appropriate.

3. Nature of the Service

Sugar Baby Online is a technology platform that facilitates communication and interaction between users. It is not a matchmaking agency, escort agency, escort service, prostitution agency, employment agency, security company, private-investigation company, financial institution, or representative of any user. The Platform does not guarantee that any user will find a Sugar Daddy, Sugar Baby, partner, friendship, relationship, meeting, financial arrangement, or other specific outcome.

4. User Relationships and User Responsibility

Each user is solely responsible for their communications, decisions, agreements, and relationships with other users. Sugar Baby Online is not a party to personal, financial, romantic, or other agreements between users and does not guarantee a user's identity, financial situation, marital status, profession, income, intentions, background, solvency, behavior, honesty, photographs, or other statements. Verification tools, when offered, reduce certain risks but are not absolute guarantees.

5. Activities and Interactions Outside the Platform

Any interaction outside Sugar Baby Online is undertaken at the users' own risk. This includes telephone calls, WhatsApp, Telegram, Instagram, Facebook, email, external video calls, money transfers, deposits, gifts, travel, hotels, restaurants,

meetings, dates, personal encounters, cohabitation, romantic relationships, financial agreements, and other activities outside the Platform.

To the maximum extent permitted by applicable law, Sugar Baby Online is not responsible for acts or omissions occurring outside the Platform, including fraud, threats, extortion, theft, assault, abuse, deception, injury, financial loss, or other harm caused by another user. Nothing in this section excludes liability that cannot legally be excluded or limited.

6. Safety Recommendations

Users should not share passwords, authentication codes, official documents, banking information, unnecessary sensitive information, or money with strangers; should consider video calls before meeting; should initially meet in public places; should tell a trusted person about meetings; preserve evidence of threats or fraud; and use the Platform's reporting tools. These recommendations are not guarantees of safety.

7. Fraud, Abuse, Extortion, Threats and Illegal Conduct

Users may not extort, threaten, blackmail, scam, defraud, impersonate, obtain information by deception, solicit money fraudulently, threaten to publish images or videos, publish private information of third parties, doxx, distribute intimate images without consent, engage in trafficking, sexual exploitation, abuse, prostitution, or other unlawful activity. Sugar Baby Online may suspend or terminate accounts and, where legally applicable, preserve evidence and cooperate with competent authorities through lawful procedures.

8. Reports, Complaints and Safety Actions

The Platform may provide reporting mechanisms for suspicious profiles, fraud, threats, extortion, harassment, illegal content, unauthorized content, impersonation, activity involving minors, and violations of these Terms. Sugar Baby Online may request information, restrict an account, remove content, preserve evidence, or take other reasonable safety measures. The Platform does not guarantee detection or prevention of every violation.

9. User-Generated Content

Users are solely responsible for photographs, videos, audio, messages, text, profiles, links, comments, posts, verification materials, and other content they upload or transmit. Users represent that they have the necessary rights and permissions. Content involving minors, unlawful material, unauthorized intimate images, threats, extortion, malware, fraud, impersonation, or promotion of illegal activity is prohibited.

10. License to User Content

Users retain ownership of their content. By uploading content, the user grants Sugar Baby Online a non-exclusive, worldwide, royalty-free, limited license to store, reproduce, process, transmit, display, and use that content only as reasonably necessary to operate the Platform, provide services, display content according to settings, moderate, prevent fraud, investigate violations, protect security, and comply with law. The license ends in accordance with applicable deletion and retention rules, except where retention is legally or operationally necessary.

11. Moderation and Automated Systems

Sugar Baby Online may, but is not necessarily obligated to, review profiles, verify accounts, review content, use automated detection systems, remove content, limit functions, suspend or terminate accounts, preserve evidence, and cooperate with authorities. Failure to detect conduct does not mean that the Company approved or endorsed it.

12. Identity Verification

Where verification is offered, it is intended to reduce certain risks. Verification is not an absolute certification of identity, a complete criminal-background investigation, a guarantee of safety, financial solvency, future conduct, or a personal

recommendation.

13. Authenticity and Account Rules

Users must provide truthful information and may not impersonate another person, use another person's photographs without authorization, create fictitious identities for fraud, create multiple accounts to evade restrictions, or sell, transfer, lend, or share accounts.

14. Messaging

Users are responsible for messages they send. Sugar Baby Online may process, moderate, block, or retain messages when reasonably necessary for security, fraud prevention, enforcement of these Terms, investigation of reports, user protection, or legal compliance. Users should not assume that communications are absolutely inaccessible to the Company under every circumstance.

15. Payments, Memberships and Renewals

Where paid services are offered, price, billing frequency, renewal terms and cancellation procedure will be displayed before purchase. Recurring subscriptions will identify the applicable price and billing period. Payments may be processed by third-party payment providers. Where processing is performed directly by a provider, Sugar Baby Online does not intend to store complete card numbers. Refunds, cancellations and consumer rights remain subject to applicable law and the terms shown at purchase.

16. Intellectual Property

The Platform and its software, design, trademarks, logos, text, interfaces, code and graphic elements belong to Sugar Baby Online or their respective owners. Without authorization, users may not copy, reproduce, modify, sell, distribute, reverse engineer, or commercially exploit the Platform.

17. Service Availability

Reasonable efforts will be made to keep the Platform available, but uninterrupted, error-free, completely secure, vulnerability-free or universal device compatibility is not guaranteed. Interruptions may arise from maintenance, updates, technical failures, attacks, providers, Internet problems, force majeure or other circumstances.

18. Limitation of Liability

TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, SUGAR BABY ONLINE SHALL NOT BE LIABLE FOR THE ACTS OR OMISSIONS OF USERS. This includes fraud, scams, extortion, blackmail, threats, theft, assaults, injuries, death, property damage, financial losses, emotional damages, relationship conflicts, breaches between users, personal encounters, activities outside the Platform, third-party content, disclosure of information by other users, money transfers between users, or activities outside the Company's control. This limitation does not exclude liabilities that cannot legally be excluded or limited.

19. Indemnification

To the extent permitted by applicable law, the user agrees to defend, indemnify and hold harmless Sugar Baby Online, its owners, administrators, employees, representatives, providers and affiliates from claims, damages, losses, costs and reasonable expenses arising from the user's violation of these Terms, content, infringement of third-party rights, fraud, unlawful use, failure to fulfill obligations toward another user, or acts outside the Platform that result in a claim against Sugar Baby Online.

20. Suspension and Termination

Sugar Baby Online may suspend, restrict or terminate an account upon reasonable suspicion of fraud, illegal activity, violation of these Terms, risk to users, abuse, harassment, extortion, impersonation, minor-related activity, manipulation, circumvention of security measures, or other conduct affecting Platform integrity. Information may be retained after termination when necessary for legal obligations, fraud prevention, dispute resolution or protection of rights.

21. Changes to the Terms

Sugar Baby Online may modify these Terms when necessary. Material changes will be communicated through reasonable available means. The current version will be available on the Platform and, when legally required, new express acceptance will be requested.

22. Privacy

Processing of personal information is governed by Sugar Baby Online's Privacy Policy, incorporated into the contractual relationship. Users should review it before registering. Where applicable law requires separate consent for particular processing, that consent will be collected separately.

23. Governing Law and Jurisdiction

These Terms are intended to be governed by the applicable laws of the United Mexican States, without prejudice to mandatory rights a consumer may have under the laws applicable to that consumer. Disputes shall be submitted to competent authorities or courts with jurisdiction under applicable law.

24. Electronic Acceptance and Evidence

Acceptance through an electronic checkbox, button, account creation flow, or other electronic mechanism constitutes consent to these Terms to the extent permitted by applicable law. Sugar Baby Online may retain evidence of acceptance, including date, time, account identifier, document version, IP address and associated technical data, subject to its Privacy Policy and applicable law.

25. Entire Agreement and Severability

These Terms, together with the Privacy Policy and policies incorporated by reference, constitute the agreement concerning use of the Platform. If any provision is invalid or unenforceable, the remaining provisions remain effective to the extent permitted by law.
